


What is the Winston-Salem Area Transportation Planning Organization?

- Our local Metropolitan Planning Organization (MPO)
 - Forum for areas with populations of 50,000+ created by Federal-Aid Highway Act of 1962
- Established 1974
- Federally <u>mandated</u> and <u>funded</u> organization charged with:
- Making multimodal transportation policy, planning, and funding decisions for the Winston-Salem Urbanized Area

Transportation Advisory Committee

 Make recommendations based upon technical expertise, local knowledge, and public input.


- Board of technical experts from municipalities and other member agencies. Forwards recommendations to Transportation Advisory Committee (TAC).
- Board made up of local elected officials from all member agencies.
 Board reviews TCC recommendation and makes final decisions on key plans, projects, and funding.

- Approximately **\$11.5 million** per year
 - Next call: January 2026




- WSATPO emphasizes project delivery
 - Contingencies
 - Supplemental Funding Call
 - Project Caps and Incentives
- All direct attributable (DA) funds
 - FHWA allocates funds to states, suballocated to MPOs
 - Provides 80% federal funding for transportation improvements
 - Reimbursement program




Strategic Prioritization

- Required by NC Strategic Transportation Investments (STI) Law
- The data-driven and local input-based process by which North Carolina evaluates and selects transportation projects for funding with state and federal funding sources
- Develops the 10-year STIP • Updated every two years

- Winston-Salem Area TPO Funding: \$2.98 million (East), \$3.35 million (West)

- Western Section Design In Progress, Construction To Begin 2026
