The Order directed the owner to **remove or demolish** the dwelling within **20** days from receipt. The time for compliance expired on 9/29/2025. The dwelling was found vacated and closed on 9/30/2025.

The notification letter was sent on 11/14/2025 advising the owner that the **Community Development/Housing/General Government Committee** of the City Council would be considering demolition of this dwelling at their meeting on 12/8/2025. The notice further advised that if the owner(s) intended to request an extension of time, they should present evidence of their intent to the Neighborhood Services Director prior to the Committee meeting.
