SUMMARY

- A total of four proposals for medical services were received by our benefits consultant Willis Towers Watson.
 - Of the 4 proposals, CIGNA, BCBSNC, & Aetna were deemed responsive. UnitedHealthcare was deemed non-responsive.
 - Of the 3 proposers, Cigna was the only firm to fulfill the M/WBE requirement by subcontracting 14% of the work to two NC HUB-certified M/WBE firms
- Since the City moved to Cigna in 2022, healthcare costs have averaged 5% annually compared to annual healthcare trends between 7% to 10% post Covid
 - No plan design or employee contribution changes since moving to CIGNA
- Pharmacy rebates have increased materially since moving to Cigna
 - ➤ BCBSNC average 2019-2021: \$1.2M annually
 - Cigna average from 2022-2024: \$2.1M annually
- CIGNA medical clinical program savings in 2024 exceeded \$3.2M
- CIGNA pharmacy utilization management program savings in 2024 exceeded \$800k
- CIGNA is willing to come on-site monthly if needed for any service issues
- 3-year Medical ASO guarantee at current rate
- Least amount of network disruption for medical and pharmacy
 - Pharmacy drug disruption was material for AETNA and BCBSNC
