Find attached a summary of neighborhood outreach and communication meeting with council woman Annette Scippio regarding the requested rezoning request for the property located at 0 Old Greensboro Rd., Winston-Salem, P.I.N. 6846-60-2001.000.

A meeting was held with Ms. Annette Scippio, council woman for the east ward on May 3, 2024 @ 2:00 pm @ City Hall. Jordan Consultants, ASLA and the property owner Mr. Broderick Williams discussed the proposed rezoning of the property located at the corner of Crews St. and Old Greensboro Rd, from RS-9 to RSQ.
