RE: LA Reynolds Rezoning Request – Public Input Meeting Summary

Dear Mr. Corley,

On April 29, 2021, members of CESO, Inc (Bob Cash, Senior Program Director, Civil Engineering, Eric Lalone, Program Director, Planning & Landscape Architecture and Lizzy Kurre, Engineering Project Coordinator) held a public input meeting at LA Reynolds Garden Showcase located at 4400 Styers Ferry Road, Winston Salem NC, 27104, at 5:00 PM to discuss the proposed rezoning of parcel number 5895-34-8992 from GB-S to RS9-S. The intent of this letter is to summarize the meeting.

April 29, 2021 Meeting Summary

Bob Cash provided a summary of the overall project with a printed display of the site plan. He described how this development would reduce the density of the land and that we are not maximizing the number of units allowed on this land under RS9-S zoning. He described how connection to Fath Road is going to be gated and only used for emergency access, there will be an amenity center with a pool, the greenway trail to provide connectivity and stormwater management. We then opened the floor for questions.

Questions were asked as followed:

Is this the same owner as before?

We were not sure who owned it prior.

Are there 150 lots or 100 lot?

There are 101 proposed lots.

Are they connected/townhouses?

No, these will all be single family residential homes.

What is the square footage of each lot?

The maximum square footage of each lot is 9,000 square feet.

How much are the houses going to sell for?

The houses will be sold in the price range of \$325,000 - \$425,000.

How will this development affect the traffic?

We have done a Traffic Impact Study and will be adding turn lanes into/out of the development on both sides of the entrance off Styers Ferry Road.

Will we be disturbing the land around the creek?

No, there is a 50 foot buffer off Reynolds Creek that cannot be disturbed, plus a 40 foot greenway easement off of that.

Who will oversee the greenway improvements?

The city will oversee the greenway improvements.

Which side of the creek with the greenway trail be on?

The city will have the final say on which side of the creek the greenway trail is built on.

Will we take trees down near the creek?

No, there is a 50 foot buffer off Reynolds Creek that we cannot disturb, plus a 40 foot greenway easement off of that.

When is construction going to begin?

Construction will possibly start the beginning of next year.

Is this a rental community?

This is not a rental community, but the houses are for sale or rent.
