G-1. Resolution Authorizing an Interlocal Agreement Between the City and County to Co-Locate the 911 Call Centers at the Forsyth County Public Safety Center at 301 N. Church Street.

Patrice Toney, Assistant City Manager, provided the staff report for this item.

In response to Council Member Mundy, Ms. Toney stated that there are no plans for the current location once vacated.

In response to Council Member Scippio, Ms. Toney stated City 911 services are not merging with the County.

In response to Mayor Pro Tem Adams, Ms. Toney explained the current location does not comply with the Category IV of the North Carolina Building Code requirements and this will be a permanent move.

Mr. Lee Garrity, City Manager, stated that the building was grandfather in regarding the code and noted it would now cost \$10 million dollars to upfit the building.

Mayor Pro Tem Adams requested a report on the history of the building including the funds spent thus far on the renovations of the building.

Council Member Larson noted his concern in paying rent for an indefinite time period.

In response to Council Member Burke, Mr. Garrity stated he would provide the information regarding the architect and engineer that helped with the renovations of the building.

In response to Council Member Larson, Angela Carmon, City Attorney, noted that there is a 180-day provision of termination in the contract.

Council Member Larson made a motion to approve this item with an amendment that the lease will be for five years with an option to renew for another five years. Motion failed for lack of second.

A motion was made by Council Member Mundy, seconded by Council Member Burke, that this item be continued to the April 11, 2022, Public Safety Meeting. The motion carried by the following vote:
