CITY MANAGER UPDATE

During the meeting, several departmental updates and announcements were shared with City Council. The Department of Transportation reported that paving work is nearly complete on the section south of Brookstone as part of the Liberty and Main Street two-way conversion project. Traffic signal installation including mass poles, arms, wiring, signals, and paving for Liberty Street, Main Street, and part of Third Street in the downtown area is tentatively scheduled to begin in August. While the project may temporarily affect normal traffic flow, all downtown businesses remain accessible, and the work is expected to be completed by the end of the summer. The Recreation and Parks Department is repaying parking lots at several community centers and parks; residents planning to visit are encouraged to check the department's website for location-specific updates. "Rock Out the Quarry," a free family event featuring a new drone show, will take place Friday, June 27th at 7:00 PM at the Quarry at Grant Park, with parking available at Bowman Gray Stadium and shuttle service provided. City offices will be closed on Wednesday, June 19th for Juneteenth and on Friday, July 4th for Independence Day. These closures may impact refuse collection, and residents are advised to check the city website or use the Winston-Salem Collections App for schedule updates. The Business Inclusion and Advancement Department will host public meetings on Tuesday, June 17th to discuss the expansion of the Neighborhood Revitalization Strategy Area, which may allow newly eligible properties to receive assistance. Additionally, on Tuesday, June 24th at 1:00 PM, the Brown School Lofts at Legacy Heights will host an event celebrating the 750th Brownfield site in North Carolina, recognizing efforts to safely redevelop contaminated or idle properties. Council members interested in attending should inform City Clerk, and registration is requested. The Police Department announced upcoming events including "Coffee with a Cop" on July 3rd from 8:00 AM to 12:00 PM at Starbucks on University Parkway, the BLET Class 80 graduation on July 18th at 10:00 AM at Calvary Baptist Church, and the Youth Citizens Police Academy, which will be held from July 28th through August 1st.

Council Member Clark addressed the city's budget challenges, emphasizing the need to balance fair employee compensation with responsible tax rates. He highlighted that firefighters currently receive double the vacation and sick leave compared to peers in similar cities, which is financially unsustainable. He stated that a new proposal aims to align firefighter benefits with industry standards, offering a 40% premium in time off due to their longer work weeks. Council Member Clark stressed that this adjustment is fair to firefighters, other city employees, and taxpayers alike. He concluded that although the decision may be unpopular, it is necessary to ensure fiscal responsibility.
