Good afternoon, Mr. Roberts!

My Franklin was kind enough to leave a voicemail for me expressing that he shared with you my concerns of the proposed Walmart grocery store. Since you are the appointed "staffer" to this particular issue, with time being of the essence, I doubt that I'll be able to reach out to all member of the Planning Board before you meet at 4:30 this afternoon but I will certainly try!

I have resided on Hundley Rd. since the inception of the Meadowlark Downs subdivision. I have lived in the development longer than anyone else- for nearly 15 years. With Brookberry Farm expanding, in addition to the middle and elementary schools that sit across the street, congestion is simply horrible at best during the morning and afternoon commutes. As I stated in my previous voicemail, gridlock from the schools alone forces a 35-40 minute drive in to Baptist where I work. I have sat in traffic on Meadowlark (if I'm lucky enough to have someone let me out) and Country Club roads for up to a half an hour before getting to Styers Ferry Rd. Forsyth Country Day School traffic adds to this as well. Taking an alternate left and going up Country Club (east) isn't a better game. Due to Calvary Baptist School, you can sit on Country Club Rd. just as long before you ever turn on Peace Haven to get to 421.

The proposed site is 3 miles from the Super Store. We have Harris Teeter already at one end of Meadowlark Drive. Another Harris Teeter is located 1.5 miles away from the proposed site. Adding this store- in addition to the Sheetz- is going to be one colossal nightmare- coming and going. The roads cannot handle the traffic as it is. Congestion is commonplace and will just worsen as a result. The Muddy Creek Greenway is a peaceful addition to this side of the city. Adding another grocery store- in a floodplain — will detract from this beautiful area. I cannot fathom the need or desire for another grocery store when we have so many options as it is. I haven't even addressed the Harris Teeter down Robinhood Rd., The Fresh Market, or Lowes. Nor have I addressed the Food Lion on Country Club, the Lowe's on Shallowford, or the Food Lion on Lewisville-Clemmons Rd. Honestly, this is just too much!

If you will please address my concerns, I would most certainly appreciate it! I take my job very seriously and have several appointments with Faculty during the time of this meeting or I would make a presence. I feel very passionately about it and just feel as though it's too much! I also suggest that your Board at least table the idea until they can read the Facebook comments. Those were just as telling.

Dear Mr. Roberts and Planning Board of WS,

I am one of hundreds of concerned constituents over the proposed new business development on the corner of Country Club and Meadowlark Roads. I have seen Mr. Roberts' email response to several others regarding this, justifying this only with the statements that this area has been zoned for this type of development since 1998 and will provide walking access to the apartments of Brookberry Park. I am concerned with these responses for several reasons.

First, let me remind the Board that very large neighborhoods, such as Brookberry Farms and parts of Century Oaks, Meadowlark Glen, and other neighborhoods located directly off of Meadowlark Road (and also many, many new developments off of Country Club) were NOT there in 1998 when this original zoning was approved. These developments have added HUNDREDS of houses, and also HUNDREDS of daily commuters. In addition, we have seen Meadowlark Elementary and Meadowlark Middle Schools almost double in volume during this time. But yet the Board still sticks by the original resolution from 1998 without any consideration for the immense growth within a mile radius of this corner? We are then told to contact the NCDOT with our concerns over the increased traffic. It is my understanding that the Planning Board is to carefully consider ALL the impacts on the community, which certainly includes traffic issues.

Not only is the traffic of major concern, but I question the decision of allowing such large businesses so close to these schools, where large delivery trucks and the constant flow of shoppers will be literally right beside thousands of children's playgrounds. How do you propose to maintain the level of safety and security at the public schools, which is already difficult, as well as the safety of the users of the Greenway???? In my opinion, the Planning Board should also be considering this factor. I assure you that the state of North Carolina will not grant these schools or teachers the additional resources to patrol the grounds and maintain a secure environment. Will Winston-Salem or even Wal-Mart be willing to fund police officers to patrol the grounds and direct the traffic that will be caused by this? Will the city of Winston-Salem also be willing to take on the cost of the large expansion of this intersection that will be needed if this is allowed? These are all issues the Board needs to take into consideration.

The second line of defense is that it provides walking access for the Brookberry Park apartments. Really? Is the existence of this new business park going to be for the sole benefit of the apartments? How does this justify anything? I think the Board needs to only examine the apartments recently built on Meadowlark/Robinhood/Olivet Church Road to see that those apartments do not support any of the businesses, such as Harris Teeter, in that adjacent business complex. 99% of the business (what little there is) is vehicular traffic. In fact, we have sadly watched as most businesses have either opted NOT to come there (i.e. Starbucks) or have gone out of business.

I strongly urge you to re-examine a proposal that was approved 15 years ago and to seriously examine all of the negative impacts expansion of business on this corner will have on this community.
