DUE PROCESS:
<b>1.</b> The current <b>Complaint and Notice of Hearing</b> was issued <b>2/27/2023</b> and service was obtained by <b>X</b> certified mail; <b>X</b> regular; <b>X</b> posting; — hand delivery and — publication on <b>3/6/2023</b> . The Hearing was held on <b>3/29/2023</b> and the owner/agent — did <b>X</b> did not appear and/or contact the Community Development Department regarding the complaint.
<b>2.</b> The <b>Finding and Order</b> was issued on <u>6</u> / <u>6</u> / <u>2023</u> and service was obtained by <u>X</u> certified; <u>X</u> regular; <u>X</u> posting; <u>hand delivery, and publication on. The Order directed the owner to <u>vacate and close or repair</u> the dwelling within <u>30</u> days from receipt. The time for compliance expired on <u>7/12/2023</u>. The dwelling was found vacated and closed on <u>7/20/2023</u>.</u>
<b>3.</b> The dwelling became eligible for demolition under the <u>X</u> six (6) month rule <u></u> 65% rule on <u>1/20/2024</u> .
<b>4.</b> The notification letter was sent on <u>12/19/2023</u> advising the owner that the <u>Community</u> <u>Development/Housing/General Government Committee</u> of the City Council would be considering demolition of this dwelling at their meeting on <u>2/5/2023</u> . The notice further advised that if the owner(s) intended to request an extension of time, they should present evidence of their intent to the Neighborhood Services Director prior to the Committee meeting. The Director <u>was X</u> was not contacted. Additionally, the owners of the property agreed to bring the property into compliance with the city's Minimum Housing Code pursuant to a forbearance agreement which the owners did not comply with.
