## 2022-2023 ANNUAL ACTION PLAN

Under the Consolidated Plan, the City of Winston-Salem receives from the U.S. Department of Housing and Urban Development (HUD):

- Community Development Block Grant (CDBG)
  - Emergency Solutions Grant (ESG)
  - \* HOME Investment Partnership (HOME)
- Housing Opportunities for Persons With AIDS (HOPWA)

#### Highlights of the 2022-2023 Annual Plan

\*The City's grant program allocations are:

CDBG: \$ 2,168,157

HOME: \$1,348,537

ESG: \$188,585

HOPWA: \$710,304

<sup>\*</sup>These amounts are estimates until HUD releases the actual funding allocations


- The City will receive \$1,065,337 of the HOME funds, and the County \$283,200.
- The City will receive an additional \$2,677,000 in Continuum of Care funds on behalf of local agencies providing homeless program services beginning in the fourth quarter of the FY23 program year.
- The City also expects to receive \$211,400 in additional ESG funds from the State of North Carolina during FY23.







#### Choice Neighborhoods Initiative (CNI)

The City is committing \$500,000 in CDBG funds per year for six years. FY23 is the third year of the commitment. Funds will continue to be used for clearance and publicly owned infrastructure, etc. in support of the development of affordable housing.
