CITY MANAGER UPDATE

During the City Council meeting, Assistant City Manager Wright Lanier introduced Michael Blair as Winston-Salem's new Housing Director, highlighting his 20+ years of experience in housing, regional planning, and community development. Blair expressed gratitude and emphasized his commitment to affordable and mixed-market housing solutions.

Transportation Director Jeff Fansler announced a new \$2 daily fare cap for WSTA riders, aligning with the upcoming launch of the UMO mobile fare app, aimed at improving accessibility and affordability.

City Manager also provided updates on ongoing projects and initiatives, including progress on the 2-way street conversion, the resident survey to evaluate city services, and new behavior guidelines for city parks in response to issues at Merschel Park.

Assistant City Manager Rowe provided an update on the Carolina Classic Fair, including early attendance numbers and new security policies. Fair Director Cheryl Clark also announced her retirement after 35 years of service.

Fire Chief Mayo received the proclamation and shared that most fires are still caused by cooking and smoking, but new risks from lithium-ion batteries and phone chargers are becoming more common and harder to regulate.

Dr. Coefield Jones, Human Resources Director, stated that the city revised its compensation policy so that only employees below the new salary minimum will automatically be brought up to that level, while any increases for employees already within the pay range will be at the City Manager's discretion, rather than an automatic 5% raise.

Assistant City Manager, Aaron King, stated the city is closing a long-unused right-of-way, as there is no existing street or future need for one, allowing adjacent property owners to build a house on the land.

Petitioner, Mike Ruthrock, 4540 Harry Street, Winston-Salem, NC 27105 provided the reasons for petition.

Seeing no one else, Mayor Joines declared the public hearing closed.
