**RESOLUTION AWARDING PURCHASE ORDER  
FOR PICKUPS**

**WHEREAS**, the Fleet Services Division has the immediate need to replace 30 pickups having high mileage and excessive repair and maintenance costs; and

**WHEREAS**, bids were received on August 20, 2019, for the purchase of 30 pickups and the following bids were received;

**WHEREAS**, on October 2, 2018, the North Carolina Sheriff's Association, a cooperative purchasing group, awarded contracts for passenger vehicles and Horace G. Ilderton, LLC of High Point, N.C. was awarded competitive bid contract #19-05-0911 per bid specifications; and

**WHEREAS**, Horace G. Ilderton, LLC has offered a quotation for 30 model year 2020 Ram 1500 pickups at a cost of \$18,617 each for a total cost of \$558,510; and

**WHEREAS**, N.C.G.S. 143-129(e)(3) authorizes "purchases made through a competitive bidding group purchasing program, which is a formally organized program that offers competitively obtained purchasing products and services at discount prices to two or more public agencies"; and

**WHEREAS**, it is the recommendation of the Finance Committee that a purchase order be awarded to Horace G. Ilderton LLC, low bidder meeting specifications, for the purchase of 30 model year 2019 Ram 1500 pickups in the total amount of \$558,510.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Winston-Salem that a purchase order is hereby awarded to Horace G. Ilderton LLC, low bidder meeting specifications, for the purchase of 30 model year 2020 Ram 1500 pickups in the total amount of \$558,510 and that all other bids be rejected. This recommendation is in accordance with N.C.G.S. 143-129(e)(3), and that the bid specifications, the company's proposal, and the City's purchase order will constitute the contract.

**BE IT FURTHER RESOLVED** that award of these purchase orders constitutes a preliminary determination as to the qualifications of the bidders. The City is not legally bound to perform the purchase orders until the purchase orders are duly executed by the City.

**BE IT FURTHER RESOLVED** that these purchase are included in the Fiscal Year 2019-20 capital budget and will be financed through the North Carolina Municipal Leasing Corporation with funding for the lease payments available in the Fiscal Year 2019-20 General Fund budget.

**BE IT FURTHER RESOLVED** that the City may reimburse itself for the capital expenditures identified herein with the proceeds from the sale of debt obligations.
