The site shall be developed in accordance with the plan approved by the Board and bearing the inscription: "Attachment A, Special Use District Permit for <a href="RM8-S">RM8-S</a> (Residential Building</a>, Duplex; Residential Building, Single Family; Residential Building, Twin Home; Swimming Pool, Private; Planned Residential Development; Residential Building, Multifamily; and Residential Building, Townhouse), approved by the Winston-Salem City Council the \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 20\_\_\_\_\_" and signed, provided the property is developed in accordance with requirements of the <a href="RM8-S">RM8-S</a> zoning district of the Zoning Ordinance of the <a href="Unified Development Ordinances">Unified Development Ordinances</a>, the Erosion Control Ordinance, and other applicable laws, and the following additional conditions be met:

#### • PRIOR TO THE ISSUANCE OF ANY PERMITS:

a. Portion of Jay Avenue to be closed as represented on W-3599 site plan.

#### • PRIOR TO THE ISSUANCE OF GRADING PERMITS:

- a. The developer shall submit a stormwater management study for review by the City of Winston-Salem. If required, an engineered stormwater management plan shall be submitted and approved. Relocation or installation of any stormwater management device into any buffer areas or existing vegetated areas designated to remain, or in close proximity to adjacent property with residential zoning, shall require a Staff Change approval at minimum and may require a Site Plan Amendment.
- b. The developer shall obtain a driveway permit from the City of Winston-Salem DOT and NCDOT; additional improvements may be required prior to issuance of the driveway permits.

#### • PRIOR TO THE ISSUANCE OF BUILDING PERMITS:

a. Any retaining wall shall be earth tone in color or shall match the color of the primary building, as verified by Planning staff.

# • PRIOR TO THE ISSUANCE OF OCCUPANCY PERMITS:

- a. The developer shall complete all requirements of the driveway permit(s).
- b. Buildings shall be constructed in substantial conformance with the approved building elevations as verified by Planning staff.
