CALL TO ORDER

Chair Clark called the meeting to order at 4:00 p.m. He stated due to the Declaration of the State-of-Emergency, the meeting is being conducted virtually. He noted that all votes by the Committee Members will be a roll call vote.

1. Review of Responses to Questions from Mayor and Council Members.

Patrice Toney, Budget Director, proved a brief report for this item.

Council Member Scippio suggested staff review the funding policies for non-profit agencies.

Council Member Clark stated he would like the funding policy for non-profits be placed on a future Finance agenda and would also like a report of the agencies that are funded by departments, such as the Police Department.

2. Finance Committee Changes to the Proposed Budget.

Chair Clark stated he has no changes to the budget and commended staff for their hard work.

Vice Chair Adams stated there would be no salary increases for anyone for the City of Winston-Salem. She said that if the County funding is received, and if it can be used in such a manner, she would like those employees that are currently making \$13.00 an hour to be increased to \$14.00 an hour.

Chair Clark stated a MOU would come before the Council regarding the County funding and that would let Council know how the funding could be used.

Council Member MacIntosh noted his concerns about the projection of future revenues.

Council Member Larson stated his concerns about projected revenues and the reserves.

Council Member Scippio stated she was concerned about reserves and asked that consideration be made for a bonus for employees instead of a pay raise if the funding allows.

Council Member Besse stated he is concerned about reserves and would like to commit to a pay raise for Public Safety Personnel.

Chair Clark asked Morticia "Tee-Tee" Parmon, Council Member Elect for the Northeast Ward, her thoughts regarding the budget. Ms. Parmon stated the City needs to be mindful of how it supports the non-profit organizations so Winston-Salem can continue to grow and not hinder growth.

Mayor Allen Joines stated he was very pleased with the City's AAA Bond rating. He noted that there could be some restraints regarding the County funding.

Chair Clark asked Lisa Saunders, Chief Financial Officer, to give a report on the AAA Bond Rating and asked her to provide a detailed report to the Council Members.

Lee Garrity, City Manager, noted Budget would provide a monthly financial report regarding revenues to the Finance Committee.

Consideration of a Recommended Budget and Property Tax Rate.
