NORTH CAROLINA FORSYTH COUNTY RESOLUTION ORDERING THE CLOSING AND ABANDONMENT OF <u>A PORTION OF BAITY STREET</u>, SILAS STREET, AND W 32<sup>ND</sup> STREET

WHEREAS, on the <u>26<sup>th</sup></u> day of <u>July 2024</u>, a petition was filed with the City Council of the City of Winston-Salem, North Carolina, to close <u>a portion of Baity Street</u>, <u>Silas Street</u>, and <u>W 32<sup>nd</sup></u> <u>Street</u>, as described on the next page; and

WHEREAS, on the 3<sup>rd</sup> day of September 2024, at a regular meeting of the City Council of the City of Winston-Salem, North Carolina, a resolution fixing the date and hour for the hearing on said petition was adopted by unanimous vote of said City Council; and the date and hour were fixed on the 7<sup>th</sup> day of October 2024, at 6:00 p.m. in the Council Chamber, Second Floor of City Hall in the City of Winston-Salem, North Carolina; and

WHEREAS, notice of said meeting was published once a week for four successive weeks in the Winston-Salem Journal, a newspaper published in the City of Winston-Salem, North Carolina, pursuant to order of the City Council in the resolution fixing the date for hearing on the above-described petition and notice of the closing and public hearing was posted in at least two prominent places along said portions of said street proposed to be closed; and

**WHEREAS**, at a meeting of the City Council of the City of Winston-Salem, North Carolina, held on the 7<sup>th</sup> day of October 2024, a public hearing was held on the petition to close and abandon said portion of Baity Street, Silas Street, and W 32<sup>nd</sup> Street; and

**WHEREAS**, notice, if required under GS 160A-299, was given to the State Department of Transportation; and

WHEREAS, it appears to the satisfaction of the City Council of Winston-Salem, North Carolina, that the closing of the indicated portion of said <u>Baity Street</u>, <u>Silas Street</u>, and <u>W 32<sup>nd</sup> Street</u> is not contrary to the public interest and that no other individual owning property adjoining, abutting or in the vicinity of said right-of-way will thereby be deprived of reasonable means of ingress and egress to his property.

**WHEREAS,** the adoption of this street closing is conditional upon the completion and acceptance of the public utilities relocation and realignment of new public right-of-way.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Winston-Salem, North Carolina, that portion of Baity Street, Silas Street, and W 32<sup>nd</sup> Street as herein referred to, and being more particularly described as follows:

landscaping, and the City of Winston-Salem's reservation of a temporary easement in the entire

area hereinabove described for the inspection, operation, maintenance, repair, rehabilitation,

relocation of landscaping, and all public utilities located therein, including water, sewer and storm

drainage lines and facilities (hereinafter "Facilities") until the relocation of the necessary Facilities

has been completed and the temporary easement or reservation is no longer needed at which point

the temporary easement or reservation will terminate automatically without further action of the

City of Winston-Salem.
