I am interested in serving on the Urban Food Policy Council (UFPC) because I want to help the council in its work to improve food access and alleviate food insecurity.

Before moving to Winston-Salem, I led a non-profit organization that operated a weekly farmers market and year-round retail store that sold products from local farmers and food producers. We served SNAP customers and customers who used fresh food “prescriptions”; administered a program that doubled SNAP benefits; created a walking program at the farmers market where anyone could earn tokens for fresh produce; and donated to the local food pantry. I observed the positive impact of these programs and the barriers people face in accessing food.

I believe I have skills and experience that can help the UFPC fulfill its responsibility to initiate and promote actions that increase food access. I have served on and led many committees/teams in my work in both for-profit and non-profit organizations, including one that focused on downtown development. My strengths include strategy, research, facilitation and excellent interpersonal skills. Activities that helped prepare me for the UFPC include: attended a meeting of the UFPC and watched recordings of previous meetings; participated in the Forsyth Food Chat meetings; participated in the Piedmont Triad Regional Food Council - Cultivate Resilience Food System Symposium; and contributed to the Food Resilience Report.

I moved to Winston-Salem in January 2023 for my husband’s job relocation. We live in downtown and I have a garden plot in the Ardmore Gateway Garden. We have made this our home and I want to work to help my new home community.
