He shared information regarding the Public Input Survey Results which included information for comparison of 11 largest cities in North Carolina regarding council size, at-large representation, population per district, term length, term staggering, mayoral voting, partisanship in elections and election cycles. He stated the recommendation of the Commission is more at-large representation on City Council by adding two additional seats to the current structure. For all other items, votes were taken to recommend maintaining current structures.
