Resolution Awarding Purchase Order for Hybrid Compact SUVs and Sedans

## **Summary of Information:**

The CID/ISB Division of the Police Department has budgeted to replace twenty vehicles that meet or exceed Fleet Services criteria for replacement. See Exhibit A for complete replacement information.

City/County Purchasing advertised a formal bid for ten hybrid SUVs and ten hybrid sedans, and four bids were received on May 10, 2024, as follows:

Upon further review, it was determined that the bid from Modern Toyota did not include the required signature authorization, and that bid was therefore rejected as non-responsive.

It is recommended that a purchase order be awarded to Toyota of Greensboro for the purchase of ten 2024 Toyota Rav 4 hybrid SUVs meeting bid specifications in the amount of \$325,000, and ten 2024 Toyota Camry hybrid sedans meeting bid specifications in the amount of \$285,000, for a total cost of \$610,000 for all twenty vehicles.

This purchase will be financed through the City's internal leasing program with funding for the lease payments in the FY 2023-24 capital equipment budget.
