WHEREAS, the low bidder, Smith-Rowe, LLC, submitted subcontracting goals other than those established for this project; however, the Citizen's M/WBE Advisory Committee determined that the low bidder did make the necessary good faith efforts to achieve the established project goals; and

WHEREAS, it is the recommendation of the Finance Committee that a contract be awarded to Smith-Rowe, LLC, the low bidder meeting specifications, for the Novack Street Bridge Replacement project in the estimated amount not to exceed \$601,118.65.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Winston-Salem that the contract for the Novack Street Bridge Replacement project is hereby awarded to Smith-Rowe, LLC in the estimated amount not to exceed \$601,118.65. The City Manager and City Clerk are authorized to execute the contract on behalf of the City, with contract

and bond forms to be approved by the City Attorney and bid deposit retained until the successful bidder has provided satisfactory contract, performance and payment bonds.

BE IT FURTHER RESOLVED that the award of this contract constitutes a preliminary determination as to the qualifications of the bidder. The City is not legally bound to perform the contract until the contract is duly executed by the City. The bid deposit may be retained if the bidder fails to execute the contract or give satisfactory surety as required by N.C.G.S. 143-129.

BE IT FURTHER RESOLVED that Smith-Rowe, LLC will be required to subcontract at a minimum .14% of this contract with certified minority-owned businesses and 3.03% with certified women-owned businesses as indicated on the Affidavit "D" submitted by the company.

BE IT FURTHER RESOLVED that funds have been appropriated in the FY2019-20 two thirds GO Bonds to cover the cost of this contract.
