## RESOLUTION AUTHORIZING THE SALE OF TEN CITY-OWNED LOTS AND \$350,000 IN GAP FINANCING FOR THE DEVELOPMENT OF SINGLE-FAMILY HOMES

**WHEREAS,** the City owns ten (10) lots identified as tax PINs 6835-61-0459, 6834-74-6448, 6834-74-6644, 6834-74-6710, 6834-74-5982, 6834-74-6735, 6834-74-5884, 6844-66-7677, 6844-66-8626, 6844-66-9626 as shown on Exhibit A; and

WHEREAS, Denton Construction Services, LLC, submitted a proposal in response to the Affordable Housing Development Small-Scale Development Request for Proposals (RFP) advertised on December 10, 2024, and closed on January 24, 2025; and

**WHEREAS,** Denton Construction Services, LLC plans to develop ten (10) single family modular homes for affordable rental (the "Project"); and

**WHEREAS,** the City agrees to convey said ten (10) lots to Denton Construction Services, LLC for \$1 each, for a sum of ten dollars (\$10); and

**WHEREAS,** the City of Winston-Salem will provide gap financing to Denton Construction Services, LLC in the amount not to exceed \$350,000 (\$35,000 per property), to be drawn down during construction to assist with developer costs; and

**WHEREAS,** the City of Winston-Salem, acting as a housing authority pursuant to G.S. 157-3(12), and pursuant to additional community development related statutes, has the authority to grant and loan funds for a housing initiative that provides or increases the supply of housing for low-and-moderate income persons; and

**WHEREAS,** under S. L. 2021-44; S.B. 145, the City of Winston-Salem has the authority to convey City-owned real property for the purpose of increasing the supply of affordable housing for low- income and moderate-income persons; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and the City Council of the City of Winston-Salem, hereby authorizes, for the purpose of increasing the supply of affordable housing for low- and moderate-income persons, the sale of ten (10) City-owned lots identified in Exhibit A, attached hereto, to Denton Construction Services, LLC, or its assigns or successors for \$1 each (\$10 in total) pursuant to Session Law 2021-44 and based upon the provisions of the City's Affordable Housing Ordinance and the Housing Justice Act; and that the City Clerk shall cause the resolution, as adopted, to be posted on the City's website at least ten (10) calendar days prior to the execution date of the conveyance.

**BE IT FURTHER RESOLVED** that the Mayor and the City Council of the City of Winston-Salem hereby authorizes a loan not to exceed \$350,000 in permanent financing from Affordable Housing Development Funds to the Denton Construction Services, LLC to develop the Project for the purpose of increasing the supply of affordable housing for low- and moderate-income persons.

**BE IT FURTHER RESOLVED** that Denton Construction Services, LLC is required to adhere to the City's Affordable Housing Ordinance (AHO) and Housing Justice Act and to complete construction of the Project and obtain certificate of occupancy within two (2) years of the fully executed award agreement/contract.

**BE IT FURTHER RESOLVED** that the Mayor and City Council authorize the City Manager to review and approve final terms and conditions, negotiate agreements, and execute all contracts and documents necessary to carry out the activities herein authorized, subject to approval as to form by the City Attorney.
