CALL TO ORDER

Present: 4 - Robert C. Clark, Denise D. Adams, Jeff MacIntosh, and James Taylor Jr.

Review of Responses to Questions from Mayor and City Council

Courtney Driver, Director of Utilities Department, made a brief presentation. Scott Tesh, Director of Budget and Performance Management, introduced responses to Questions from Mayor and City Council.

2. Finance Committee Proposed Changes to the Budget.

Scott Tesh, Director of Budget and Performance Management made a brief presentation.

A motion was made by Council Member Clark that the staff changes totaling \$234,000 be added to the proposed FY 2023-24 budget as follows: \$20,000 for Youth Advisory Council travel in the General Fund covered by sales tax and \$214,000 in the Transit Fund covered by Transit Fund balance be approved. This motion was seconded by Council Member Taylor and carried by the following vote:

A motion was made by Council Member Clark that the Proposed General Fund budget be increased by \$1,630,000 to increase firefighter pay minimums by \$3,000 and provide 4% compression adjustments to current certified fire staff. This would be covered by reallocating 0.6 cents of the property tax rate from the Debt Service Fund to General Fund be approved.

This motion was seconded by Council Member Taylor and carried by the following vote:

A motion was made by Council Member Clark that the Proposed General Fund budget be increased \$87,500 for community agencies as discussed to be covered by reallocating 0.03 cents of the property tax rate from the Debt Service Fund to the General Fund be approved.

A motion was made by Council Member Clark that the proposed General Fund budget be increased \$100,000 to provide a transfer to the Capital Projects Fund for Historic Bethabara Park project, covered by General Fund balance, and that
