Historic Resources staff has reviewed the one property that is scheduled to go before the Community Development/Housing/General Government Committee on October 14, 2024 for demolition consideration. Per the list provided by Community Development, the proposed demolitions are:

1. 311, 33, and 315 Lakeview Blvd – East Ward
2. 217, 219, 221, and 223 East Drive -East Ward

The buildings are not a Local Historic Landmarks nor located within a locally designated historic district nor have been designated to the National Register of Historic Places. Therefore, there are no recommendations for these structures currently.
