**ORDINANCE AMENDING SECTION 42-122(f) OF THE CITY CODE  
RELATING TO 25 MILES PER HOUR SPEED LIMITS ON CITY STREETS**

**BE IT ORDAINED**, by the City Council of the City of Winston-Salem as follows:

**SECTION I.** Section 42-122(f) of the City Code relating to 25 miles per hour speed limits is amended by adding the following subsection to the end thereof:

“Brookberry Farm Road from Meadowlark Drive to Brookberry Farm Circle.”

“Summer Hill Lane from Heron Ridge Road to end of Cul-de-Sac.”

“Summer Hill Way from Summer Hill Lane to end of Cul-de-Sac.”

“Bridlespur Court from Brookberry Farm Road to end of Cul-de-Sac.”

“Fresh Field Lane from Brookberry Farm Road to Heron Ridge Road.”

“Garden Park Lane from Brookberry Farm Road to Heron Ridge Road.”

“Heron Ridge Road from Meadowlark Drive to Brookberry Farm Road.”

“Osprey Ridge Road from Summer Hill Lane to Heron Ridge Road.”

“Spindletop Court from Osprey Ridge Road to end of Cul-de-Sac.”

“Birmingham Court from Osprey Ridge Road to Osprey Ridge Road.”

“Stable Bend Lane from Heron Ridge Road North to Dead End.

“Stable Bend Lane from Heron Ridge Road Southwest to Heron Ridge Road Southeast.”

“Autumn Park Circle from Heron Ridge Road to Heron Ridge Road.”

“Addlestone Road from Autumn Park Circle to Sweetgrass Trail.”

“Sweetgrass Trail from Trent Creek Lane North to circle turn around.”

“Trent Creek Lane from Addlestone Road to Sweet Grass Trail.”

“Windalier Lane from Sweetgrass Trail to Brookberry Farm Circle.”

“Downing Creek Circle from Windalier Lane to end of Cul-de-Sac.”

“Mossbank Lane from Downing Creek Circle to Lyndale Drive.”

“Cedarmere Drive from Windalier Lane to Wood Duck Lane.”

“Wood Duck Lane from Cedarmere Drive to Dead End.”

“MapleCHASE Road from Cedarmere Drive to Dead End.”

“Reynolds Creek Circle from Brookberry Farm Circle to Brookberry Farm Circle.”

“Goldenberry Court from Windalier Lane to end of Cul-de-Sac.”

“Berryhill Lane from Cedarmere Drive to Fernhill Road.”

“Fernhill Road from Windalier Lane to Brookberry Farm Circle.”

“Brookberry Farm Circle from Cedarmere Drive to Rosewind Lane.”

“Foxgate Circle from Brookberry Farm Circle to Rosewind Lane.”

“Walnut Park Lane from Foxgate Circle to Brookberry Farm Circle and Rosewind Lane.”

“Windflower Road from Foxgate Circle to Rosewind Lane.”

“Silverbrook Court from Foxgate Circle to end of Cul-de-Sac.”

“Rosewind Lane from Brookberry Farm Circle to Meadowlark Drive.”

“Hundley Road from Rosewind Lane to Rosewind Lane”

“Shoal Creek Lane from Hundley Road to Hundley Road.”

“Fern Bank Circle from Hundley Road to Hundley Road.”

**SECTION II.** This ordinance shall be effective upon adoption by the City Council and upon the erection of appropriate signs giving notice thereof.
