To ensure that these installations are completed and the vehicles returned to service in a timely manner, WSPD determined it to be most effective when utilizing two different businesses for these services. Historical spend information indicates that WSPD will spend an estimated total of \$90,000 per year for these services. The City advertised a Request for Proposals to provide installation services for lights, radios, and other electronics on police pursuit vehicles and proposals were received September 6, 2019, from the five businesses as follows: City/State Winston-Salem, NC Mobile Communications America, Inc. d/b/a Amerizon Wireless HELS (Hill's Emergency Light Sales), LLC Sanford, NC Reisenweaver Communications Inc. Winston-Salem, NC d/b/a RCS Wireless Technology Ilderton Conversion of Charlotte, LLC High Point, NC d/b/a Ilderton Emergency Lighting Mobile Communications, Inc. Winston-Salem, NC A committee of eight staff members from the Police Department, Fleet Services, and the Office of Business Inclusion and Advancement was selected to evaluate the proposals received. Respondents were evaluated for selection based on the two proposers most qualified to meet the specification requirements. **Committee Action:** Finance 10/14/19 Committee Approval Action For Unanimous **Against**

Remarks:

Major criteria considered in these evaluation included, but were not necessarily limited to:

- A. M/WBE Commitment Proposer's efforts to comply with all the terms and conditions of the City of Winston-Salem's Minority and Women Business Enterprise (M/WBE) Program through award of subcontracts to minority and women owned business enterprises and utilization of minority and women owned business enterprise suppliers to the fullest extent consistent with the efficient performance of this contract
- B. Location of Business Physical location of proposer's place of business.
- C. **Price -** Quoted pricing in relation to other proposals received
- D. **Experience** Previous relevant experience performing the same or similar services, preferably for another government entity.

Based upon the committee's assessment, it is recommended that a contract for installation services of lights, radios, and other electronics on police pursuit vehicles in the estimated amount of \$60,000 be awarded to Mobile Communications America, Inc. d/b/a Amerizon Wireless and a contract in the estimated amount of \$30,000 be awarded to HELS (Hill's Emergency Light Sales), LLC for an annual total of \$90,000. Terms of the bid reserve the right for the City to extend these service contracts for as many as three (3) additional twelve (12) month periods, for a potential total estimated contract value of \$360,000.
