Subject: 2018 Housing Bond Budget Update

In August 2019, Community Development Department staff presented a proposed budget for allocation of the 2018 Housing Bond funds, to support implementation of key recommendations, objectives, and relevant strategies contained in the 2018 *Winston-Salem/Forsyth County Housing Study and Needs Assessment*.

The budget approved by Council included the following:

- \$2.5M Targeted acquisition & site prep, including City-owned properties and tax foreclosed properties, in targeted development zones (TDZs)
- \$.25M Employer Assisted Housing pilot in TDZs (in partnership with area employers)
- \$3.5M Development incentives in tandem with TDZs
- \$2M TURN round 2, including approximately \$.5M for administrative costs
- \$.75M Enhanced code enforcement and implementation of Center for Community Progress recommendations to address vacant, abandoned and deteriorated properties
- \$1M For Everyone Home match and implementation of recommended strategies

To date, investments and commitments of housing bond funds have occurred as follows:

Consistent with the application to HUD for the \$30 million Choice Neighborhoods Implementation grant, the City has committed \$3 million of Housing Bond funds to support transformation of Cleveland Avenue Homes.

Efforts to initiate the Employer-Assisted Housing pilot are underway, with the Affordable Housing Coalition leading the effort. Conversations are in progress with two area healthcare employers, and consensus on proceeding with a collaborative effort is expected by the first quarter of 2021.

Funds utilization for the second round of the TURN program has begun, with the Southeast Ward being the first to spend its full allocation of 2014 funds and eligible to draw from the current round.

The ForEveryoneHome initiative is nearing the completion of the first round of community engagement and identification of potential policy recommendations for Council consideration. Remaining funds on hand will support continued community engagement and anti-displacement policy implementation in neighborhoods vulnerable to gentrification.
