

W-3663 New Ashley Elementary School Neighborhood Outreach Report

On September 10, 2025, two hundred thirteen (213) neighborhood outreach letters were sent to property owners within 500 feet of the subject site and beyond to invite them to a neighborhood meeting. The letters provided a summary of the rezoning request and a copy of a conceptual site plan for the proposed new Ashley Elementary School site. The letter also provided the location and date for the proposed neighborhood meeting. Contact information for Luke Dickey with Stimmel Associates as representative of the petitioner was provided if a neighbor had any questions and/or was unable to attend the meeting.

The meeting was held on Thursday, September 25 at 6pm at New Hope Missionary Baptist Church located at 1201 New Hope Lane. The meeting was facilitated by Luke Dickey with Stimmel Associates. A representative from Winston-Salem Forsyth County Schools was available to answer questions as well as the project architect. Councilmember Barbara Burke and Northeast Ward Community Liaison Tamra Bradshaw-Sheller also attended the meeting. Thirteen (13) neighbors attended the meeting. Primary concerns focused on the following items:

1) Neighbors primarily wanted to understand the purpose of the rezoning request.

Response – The primary purpose was to rezone the site to a single zoning district to establish uniform building setback requirements for an oddly shaped and tight site. RS7 provided the greatest flexibility. One parcel on the corner of Twenty First Street and Blaireast Lane was to be rezoned to IP to permit a electronic message board sign.

2) One neighbor questioned whether the zoning request included and would affect their property.

Response – The zoning request was specific to the proposed school property and would not affect their property.

3) One neighbor asked whether their property value would be affected.

Response – typically with reinvestment and development within areas, property values within the surrounding vicinity may increase. However, there are too many other factors that affect property values to state positively whether the development of a school in the area would directly affect property values.

4) One neighbor expressed concerns about air pollution in the area with the existing US 52 traffic and if the school system proposed utilizing diesel buses. Would the school system invest in electric buses?

Response – Standard buses for the school system utilize diesel buses. There are a few gasoline buses in the system that could potentially be utilized. Electric buses are an option within the system today.



5) School generated traffic was a concern and questioned how it would be managed.

Response – Plans are in the process of being developed and will be reviewed by WSDOT. A traffic management plan shall be developed for how car drop-off and pick-up shall be directed. Initial plans are for the bus lot to be located off New Hope Lane. This will be looked at closer when plans are submitted to Planning Board review.

- 6) It was shared with neighbors that portions of existing roads within the project area and that bisect the site shall require closure with approval of City Council. These roads included a portion of Bethlehem Lane, Ophelia Drive, and Wellbridge Court. This would be through a separate submittal process.
- 7) It was shared that once the site plan is developed for the school, approval of the plan would be by the Planning Board. This will take place after the zoning request.
- 8) The next significant dates for the Planning Board Meeting and City Council Meeting were shared with the neighbors.

Neighborhood Outreach Letter

Dear Neighbor,

You are receiving this letter because your property is within 500-feet or in proximity of a proposed rezoning and are invited to a neighborhood meeting regarding the rezoning request.

The proposed rezoning request is to rezone multiple parcels owned by the Winston-Salem Forsyth County Board of Education for the new Ashley Elementary School site. The overall site is approximately 8.14 acres located between Twenty First Street to the north, Blaireast Lane to the east, New Hope Lane to the south, and Liberty Street to the west. There are multiple zoning districts on the proposed site which includes Residential Multifamily, Single Family, and Pedestrian Business. The rezoning request is to rezone to one zoning district such as Residential Single Family (RS7), and Institutional Public (IP) and limit the uses to Public School and Recreational Services, Outdoor.

Please refer to the attached location map of the site to be rezoned.

The proposed rezoning will be reviewed by the Winston-Salem/Forsyth County Planning Board who provides a recommendation for approval or denial. The Winston-Salem City Council is the final approval authority.




