Historic Resources staff has reviewed the six properties that are scheduled to go before the Community Development/Housing/General Government Committee on November 10, 2020 for demolition consideration. All six properties have been severely damaged by fire. Per the list provided by Community Development, the proposed demolitions are:

1. 1805 Center Street
2. 1728 Longview Drive
3. 3720 Tech Avenue
4. 1529 East Twenty-Third Street
5. 4497 Ogburn Avenue
6. 5311 Silas Creek Parkway

None of the buildings are Local Historic Landmarks or located within locally-designated historic districts.

- 1) 1805 Center Street – Centerville Historic District

The house at **1805 Center Street** is a ca. 1918 one-story, side gable bungalow, featuring a shed-roof porch; vinyl siding; one-over-one replacement windows; knee braces; square posts; exposed rafter tails on porch. The building is a contributing structure to the Waughtown-Belview Historic District. If demolition for this structure is approved, Historic Resources staff requests that the Community Development Department have the structures professionally photo-documented and submit the photos to the Forsyth County Historic Resources Commission.

2) 1728 Longview Drive – Waughtown-Belview Historic District
