Summary of Information

This project will provide a longer walking trail and a new fitness equipment location at Helen Nichols Park for residents. The walking trail will maximize use of the property by creating a large loop adjacent to Carl H. Russell Community Center, all the way to the rear of the park. The walking trail will be a combination of crushed stone with the park and HDPE boardwalk on the east side, with several new steel benches throughout. The project also will include a six-piece fitness circuit on poured-in-place rubber surfacing under a shade structure.

Following a failed attempt to award a contract in early 2024, City/County Purchasing advertised a formal construction bid on June 17, 2025. No bids were received on July 8, so the project was re-advertised as allowed by N.C.G.S. 143-132 for July 15, 2025, with one bid received from Hodgin Construction Company in the total amount of \$1,069,550.

Since the bid exceeded the construction budget of \$992,000, staff engaged with Hodgin Construction Company to discuss cost reduction options since negotiations with the low bidder are permitted by N.C.G.S. 143-129(b). The original project scope included a concrete path on the west side of the park that would remove eighteen feet of the parking lot serving the tennis courts and extend the walking path with a heavily

landscaped berm. This element has been removed to keep the project cost within budget. The Recreation and Parks Department requests to award a construction contract for the not-to-exceed total amount of \$992,000.

Analysis of Fiscal Impact

This project is funded from Limited Obligation Bonds (LOBS) that the City Council approved as part of the FY 2022-2023 budget. The budget, including design and construction, totals \$1 million.
