Summary of Information:

On June 17, 2022, the City Council approved \$719,000 of Two Thirds General Obligation Bonds and on July 1, 2022, \$1,000,000 of Limited Obligation Bonds, for improvements to Winston Lake Golf Course. This is a total of \$1,719,000 for improvements. The City advertised bids for tree removal to Winston Lake Golf Course. The scope of work will include, but is not limited to clearing, grubbing, and off-site disposal of trees, brush, shrubs, logs, down timber, stumps, roots, and installation of tree skimmers.

On December 29, 2023, the City posted Request for Proposal (RFPs) to perform construction services. Four (4) firms submitted RFPs. Upon initial review, one proposal was received that did not include all required information relating to M/WBE, and therefore, the proposal was deemed non-responsive.

Proposals were received on January 19, 2024, with a summary of applicants as follows:

Due to changes of the project specifications, the project was rebid on June 13, 2024. The rebid yielded seven responses. Upon initial review, two proposals were received that did not include all required information relating to M/WBE, and therefore, the proposals were deemed non-responsive. Proposals were received July 16, 2024, with summary of applicants as follows:

The terms of the bid document specified detailed evaluation, criteria of M/WBE commitment, price/value, understanding of the project and approach, project timeline, and manpower, and years performing similar. An evaluation panel of staff members from Diversity, Equity, and Inclusion; Vegetation Management and Recreation and Parks reviewed the proposals received. See Exhibit A for the detailed scores.

Based on the evaluation panel's assessment, it is recommended that a contract for Winston Lake Golf Course Tree Removal project be awarded to W Brown Construction, LLC, in the amount of \$720,657.27.

M/WBE comment: This project was advertised on the City and state websites and sent directly to eighty-seven (87) general contractors. Notifications were sent to all local M/WBE and regional HUB businesses on a bi-weekly basis.
