**ORDINANCE AMENDING THE ANNUAL APPROPRIATION AND TAX LEVY
 ORDINANCE FOR THE CITY OF WINSTON-SALEM, NORTH CAROLINA
 FOR THE FISCAL YEAR 2020-2021**

BE IT ORDAINED by the Mayor and City Council of the City of Winston-Salem that the Annual Appropriation and Tax Levy Ordinance for the Fiscal Year 2020-2021 be amended to cover changes in the following funds as described herein.
