*Eric Billings, Nature's Value, stated this is an exciting opportunity for the company to move to the City of Winston-Salem. He provided information regarding the new and transferring jobs and about charitable donations to citizens of Winston-Salem.*

*Mark Owens, President of Greater Winston-Salem Inc. thanked Mr. Billings and his team for considering Winston-Salem, the Mayor and City Council for considering this opportunity as well as Ms. Lee and Mr. Millett for their roles in helping in this process.*

*In response to Mayor Pro-Tem Adams, Ms. Lee stated the State has approved a Job Development Investment Grant Agreement of \$1.954 million dollars which will be paid out over a 12-year period.*
