



Said portion of the 10' alleyway between PIN 6835-77-5829 and PIN 6385-77-5707 was dedicated to public use upon the public records appearing in the Office of the Register of Deeds of Forsyth County, North Carolina. Its use as a street or public way is unnecessary for the normal flow of traffic through the surrounding area.

## II.

Your petitioner respectfully petitions that the following described portion of said 10' alleyway officially be closed and abandoned: **(insert property description of the property listed above)**


The alleyway mentioned above is approximately 10 feet wide (north to south) and approximately 130 feet long (west to east). It is between the 3 lots and connects into a rainwater drainage easement on it's west side. The alleyway is currently overgrown and seems to serve no practical purpose to the residents on N. Dunlieth Ave.

## III.

No individual owning property in the vicinity of the aforesaid entirety of the 10' alleyway between PIN 6835-77-5829 and PIN 6385-77-5707 will be deprived of reasonable means of ingress to and from his property, nor is the closing thereof contrary to the public interest.

WHEREFORE, your petitioner respectfully requests the City of Winston-Salem, acting through its City Council to close and abandon for street purposes that entirety of said 10' alleyway between PIN 6835-77-5829 and PIN 6385-77-5707 described, all as provided by law, particularly by Section 160A-299 of the General Statutes of North Carolina.
