The follow are my answers to your questions based on the information I have available to me.

At this point, staff is not aware of whether the properties will have Section 8 housing available.
2. Are the dwelling units- apartment buildings? If yes, how many apartments are within a unit?
The proposal is for townhome units, with each building having 4 townhomes within it.
3. Will this community gave a HOA?
At this point, staff is not aware of whether the properties will have a HOA.
4. How will you handle the flow of traffic for the neighbors? This back way out of Teague Rd is used often because of the traffic on Hgwy 109-Thomasville Road. This will cause delays.
Winston-Salem Department of Transportation and North Carolina Department of Transportation have studied Teague Road, and the plan is to eventually modern Teague Road between Old Lexington Road and Thomasville Road. These improvements will increase both safety and capacity of Teague Road.
