In response to Council Member Clark, Ms. Hamilton stated 100% of the funds will be spent in Forsyth County and Winston-Salem.

In response to Council Member Mundy, Ms. Hamilton explained the education level and noted the interns must be 18 years of age and from a historically under-served community.

She clarified the jobs and task of each intern and stated the instructors would be from the North Carolina School of the Arts.

Griff Morgan, spokes person for the Arts Base School, explained the history of the school and why this location was intentionally selected for the new school noting the proximity to Winston-Salem State University and University of North Carolina School of the Arts.

In response to City Attorney Carmon, Mr. Morgan clarified that the entity that will hold title to the land is Arts Based School Supporting Organization.

Mayor Pro Tempore Adams and Council Member MacIntosh noted their focus is on affordable housing and this land was set aside for that purpose.

A motion was made by Mayor Pro Tempore Adams, seconded by Council Member MacIntosh, item G-3 be Forwarded Without Recommendation. The motion carried by the following vote:
