Zoning Petition of City of Winston-Salem, Docket W-3661

AN ORDINANCE AMENDING THE WINSTON-SALEM CITY ZONING ORDINANCE AND THE OFFICIAL ZONING MAP OF THE CITY OF WINSTON-SALEM, N.C.

BE IT ORDAINED by the City Council of the City of Winston-Salem as follows:

<u>Section 1</u>. The Winston-Salem City Zoning Ordinance and the Official Zoning Map of the City of Winston-Salem, N.C. are hereby amended by changing from <u>County LI-S</u> to <u>City LI-S</u> the zoning classification of the following described property:

The property described for case W-3661, by the survey for PIN 6863-56-3853.000, as submitted this day, 07/21/2025, is correct and further action toward the rezoning of this property may continue. Rezoning exhibit survey is attached.

Section 2. This Ordinance is adopted after approval of the site plan entitled 4015 Wallburg Road Zoning Conversion and identified as Attachment "A" of the Special Use District Permit issued by the City Council the _____ day of ______, 20___ to City of Winston-Salem.

<u>Section 3</u>. The City Council hereby directs the issuance of a Special Use District Permit pursuant to the Zoning Ordinance of the *Unified Development Ordinances* for a development to be known as <u>4015 Wallburg Road Zoning Conversion</u>. Said Special Use District Permit and site plan with associated documents are attached hereto and incorporated herein.

<u>Section 4</u>. This Ordinance shall be effective from and after its adoption.
