(W 3392) for a Mining, Quarry, or Extractive Industry use in a GI zoning district: property is located at the western terminus of Pinebrook Knolls Drive, south of East Hanes Mill Road – Containing approximately 16.6 acres located in the NORTHEAST WARD (Council Member Burke). [Planning Board recommends approval of petition.]

*The Mayor read the rules and regulations regarding the Quasi-Judicial Public Hearing procedures:*

*This is a Public Hearing regarding the petitioner's application for a Special Use Permit for a mining, quarry or extractive industry use in a GI zoning district. The process for hearing such a request is quasi-judicial. Speakers must present testimony and evidence under oath. Speakers should rely on their own information and not base their remarks on what someone else has said or knows. Council must only consider evidence provided at the hearing and disclose communications, if any that have occurred outside of the hearing. The applicant and other witnesses have the right to ask questions of each other. All testimony and evidence must relate to the four findings that Council must make. The four findings are shown on the screen. The process also requires Council to issue a special use permit only when it is able to make an affirmative finding as to each of the four findings. The applicant has the burden of proof as to the second and third finding. The opposition has the burden of proof with respect to the first and fourth finding. He opened the*

*Public Hearing and asked that anyone who intends to speak for or against this item will need to come forward to be sworn in.*

*Council Member Besse noted his concerns regarding the simultaneous communications bill, and asked for this specific bill to be pulled from the package.*

*Council Member Adams explained why she asked the City Attorney to compose this bill. She noted that with today's technologically advanced society, we should allow simultaneous communication for medial necessities.*

*Council Member Besse concurred that a medical reason would be a valid reason to allow this, but the way the bill is currently written is too broad and would allow for reasons that he did not believe would warrant simultaneous communication.*

*Council Member Scippio noted that we are representing citizens in the 21st century, and she would rather Council Members be able to participate remotely, than not at all if other commitments interfered with City Council business.*

*Council Member Larson pointed out that the Council is a local body of government, and Members are only required to attend 3 or 4 meetings per month.*

*Council Member Clark voiced his support for Council Member Besse's substitute motion, and added that Washington DC, Raleigh, nor anybody else in the County allowed simultaneous communication.*

*Mayor Pro Tempore Burke stated that if this bill were to pass, she does not believe that our Council would abuse the right, and would only use it when necessary.*

*Council Member MacIntosh recommended making the language in the bill more clear, prior to sending it to Raleigh.*
