

3. NEIGHBORHOOD MEETING SUMMARY:

- On Monday, May 19, 2025, MLA Design Group, along with the property owners/applicant from Triple A Mart Mr. A.G. Qureshi and Mr. A.K. Alkolany sponsored a presentation to the local neighborhood to present plans for their proposed development "The Shoppes at Waughtown Circle" on 4.5 acres at the intersection of Thomasville and East Clemmonsville Roads.
- Two weeks prior to the meeting a notification of this meeting was sent via 1st class mail to all 135 property owners within 500' of the subject property inviting them to this informational, community outreach meeting. An email was also sent to Council Member James Taylor and his community Assistance Liaison Yolanda Taylor inviting them to this meeting. Yolanda Taylor attended the meeting for CM Taylor as he already was scheduled to attend the City Council hearing that evening.
- Approximately 25-30 people attended the neighborhood outreach meeting which lasted from 5pm-6:30pm. Of those in attendance, 25 people signed in (see attached sign in sheet).
- Mr. Scott Miller, Landscape Architect and President of MLA Design Group introduced himself and let everyone know that this meeting was to present a project that would be going through the rezoning process, and that this community outreach was one step in the process. Mr. Miller thanked everyone for taking the time to be here and gave an overview of the site and the proposed project including the reason/rationale for the rezoning request. Mr. Miller explained that NCDOT, as part of their proposed round about project at the intersection of Thomasville and East Clemmonsville Roads, was taking right of way from the subject property which resulted in the demolition of his client's existing, family-owned convenience store operation. The 4.5 acres property that Mr. Qureshi and Mr. Alkolany owns is currently zoned RS-9 and does not allow anything but residential on the property. The owners would like to re-establish their family owned, convenience store establishment back on the property and develop the remainder of the property together into a well conceive, neighborhood scale mixed use project. This mixed-use project would consist of appx. 27,000sf of small retail, restaurant, café', service, office and potentially residential uses aimed at servicing the needs of the local community. Mr. Miller explained that the proposed PB-S (Pedestrian Business-Special Use) would require that the applicant follow the site-specific site plan and proposed uses that accompany the rezoning application.
- Mr. Miller presented the site plan including such items as buffers, circulation and stormwater controls and then opened the floor for questions and answer sessions. He also indicated that everyone could review the plans in detail after the meeting and/or are welcome to come to the Planning Board meeting on June 12, 2025, and the City Council meeting likely to be held in August.

3. NEIGHBORHOOD MEETING SUMMARY: (continued)

- This meeting was an open forum type meeting allowing questions after the initial presentation. Questions from those in attendance varied but most concerns sere focused on the increase in taxes they were experiencing and the potential for that to increase based on this development and on traffic issues. Many of those in attendance were aware of NCDOT's plan for the round about however many were not aware or were uncertain of how it would function. Mr. Miller stated that the NCDOT would likely make things much better in this areas and that the NCDOT would not spend the significant resources on the project unless they felt confident that this would help prevent significant accidents and help improve traffic flow once travelers got used to it. He also mentioned that even though the TIA (Transportation Impact Analysis) indicated that this project did not forecast a significant impact to traffic, that the applicant would still be required to follow the recommendations of the TIA and any NCDOT/WSDOT requirements.
- There were some question to the landowner/applicant in reference to his use of minority
 contractors and use of local/minorities for the construction and management of the project. The
 applicant, who is a minority, indicated he has used minority labor in the business he had
 previously had on site and would likely continue to do so; however, no contracting group had
 been secured to date.
- The meeting concluded at 6:30pm and lasted approximately 1-1/2 hour. There were comments of concern as expressed above and comments in support of the project indicating that it was a good investment back into the community. There were 3 phone calls made to MLA prior to the meeting. One just indicating they would be attending the meeting, one from a landlord in the area wanting to make sure we were aware that a rezoning would be required and to consider a residential component and one call from a landlord in the area that supported the proposed mixed use and saw it as a positive investment in a community in need of such and offering up his support of the project.
- There were no materials distributed at this meeting, but attendees were encouraged to attend
 the public hearings and/or contact MLA with any further questions. To date(5/29/2025), MLA
 has not received any additional calls.
