Summary of Information

The City has over 400 facilities at varying ages and conditions. In order to create an in-depth building inventory, evaluate current building conditions, and determine current and future maintenance requirements, the City issued a Request for Proposal for Facility Condition Assessment services. The results of the assessment will not only identify the current state of City owned facilities, but also identify and prioritize the operation, maintenance, and future replacement costs of each facility.

After reviewing proposals and conducting interviews with the top three scoring vendors, staff recommends that the contract for the Facility Condition Assessment ("FCA") be awarded to ALPHA Facilities Solutions, LLC ("ALPHA"), a minority and veteran owned business.

The FCA will include the following key services:

- On-site inspection of every facility and building component, including assigning a condition rating for each facility
- Energy efficiency audit at select facilities
- Lifecycle cost analysis of building systems including current capital

investment, operating costs, and anticipated future capital replacement costs

- Corrective action recommendations, prioritizations, and costing
- Data collection and asset tagging for integration into future asset management and work order software
- Preventative maintenance planning and labor resource analysis.

ALPHA also provides additional services that assist clients with accessibility surveys and assessments, ongoing data sustainment efforts, performance benchmarking, periodic data audits and updates, advanced data analytics, assistance with asset management and work order software, and other related asset management services.

Staff requests approval of a contract with ALPHA to perform FCA services in an amount not to exceed \$649,854. Staff also requests approval to enter into the contract as a multi-year year master services agreement for a term not to exceed five years, with authorization to request future task orders for additional services based on need and available budget, for a total contract increase not to exceed the City Manager's approval authority of \$500,000.

Analysis of Fiscal Impact

The Fiscal Year 2025-26 Property & Facilities Management budget includes \$800,000 for the Facility Condition Assessment, which is sufficient for not only the initial assessment, but also some of the additional services noted above.
