- In collaboration with the North Carolina Department of Information Technology and NC State University's Institute of Emerging Issues, Forsyth County is among a growing number of communities across the state who are working to ensure that every local resident has the tools, knowledge, infrastructure, and financial ability to access high-speed Internet in their homes.
- The North Carolina Department of Information Technology has set a goal of making NC the first state in the nation in which every county has a digital inclusion plan in place. We seek to develop a comprehensive Digital Inclusion plan for Forsyth County. We believe that, by making Internet adoption an option for every local resident, we will be able to achieve Digital Equity in Forsyth County.

WHAT IS THE DIGITAL DIVIDE?

- The Digital Divide refers to the gap between those who have access to technology, the internet, and digital literacy training and those who do not.



DIGITAL INCLUSION

- Digital Inclusion refers to the activities necessary to ensure that all individuals and communities, especially underrepresented populations, have access to and use of information and communication technologies.
- Digital Inclusion requires intentional strategies and investments to reduce and eliminate historical, institutional, and structural barriers to access and use technology.
- Digital Inclusion is the path whereby a community achieves Digital Equity.

5 COMPONENTS OF DIGITAL INCLUSION

- 1) Affordable, robust broadband internet service;
- 2) Internet-enabled devices that meet the needs of the user;
- 3) Access to digital literacy training;
- 4) Quality technical support; and
- 5) Applications and online content designed to enable and encourage self-sufficiency, participation and collaboration.



DIGITAL EQUITY

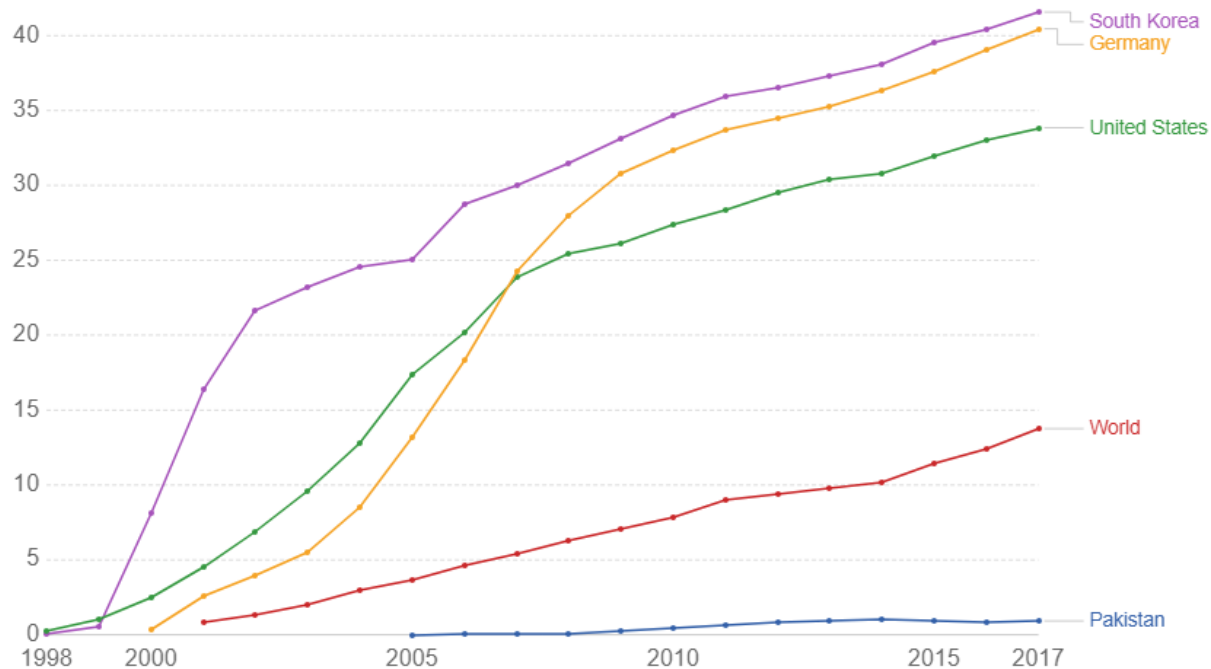
Digital Equity is a condition in which all individuals and communities have the information technology capacity needed for full participation in our society, democracy and economy. Digital Equity is necessary for civic and cultural participation, employment, lifelong learning, and access to essential services.

WHAT IS INTERNET ADOPTION?

Broadband subscriptions per 100 people

Broadband subscriptions refer to fixed subscriptions to high-speed access to the public Internet (a TCP/IP connection), at downstream speeds equal to, or greater than, 256 kbit/s.

Internet Adoption refers to the percentage of the population that subscribes to a broadband service.

WHY DOES INTERNET ADOPTION MATTER?

- Being able to access high-speed Internet in the home gives individuals the ability to connect to valuable educational, healthcare, and employment resources that can improve their social mobility as well as their quality of life.
- Research shows that high levels of broadband availability are associated with lower total unemployment and higher numbers of businesses and jobs in community.



STATISTICS IN NC

- ❖ Statewide, only 62.6% of households subscribe to high-speed Internet services.
- ❖ Nearly 6% of North Carolina households rely on smartphones solely for their Internet access.
- ❖ More than 12% of North Carolina households have no computers or Internet-capable devices in the home



NEXT STEPS FOR THE FORSYTH COUNTY DIGITAL EQUITY COMMITTEE

- Inform our community of the work of the Steering Committee through a public launch
- Assess current state of digital inclusion in Forsyth County, including asset and needs inventories
- Engage the community members (especially those from underserved communities) in sharing data, stories, and resources to shape and inform the plan
- Create comprehensive plan for digital inclusion including recommended strategies, necessary resources, implementation strategies,
- Publish the completed plan in a public platform for community
- Collaborate on action plans to implement plan recommendations
