Special Meeting of the Finance Committee Budget Workshop Virtual Meeting June 10, 2021

CALL TO ORDER

Chair Clark called the meeting to order at 4:00 p.m. and stated due to the Safer-At-Home Order, all Committee Members are participating virtually. For virtual meetings, Committee Members will be muted until asked to be heard. When there is a vote, it will be necessary to conduct a roll call vote. A Committee Member will be recognized, raise their hand, and state their vote. He announced the regular scheduled Finance Committee will 4:00 p.m.on June 14, 2021 and **Community** the Development/Housing/General Government Committee will begin at 3:30 p.m. on June 15, 2021.

1. Review of Responses to Questions from Mayor and Council Members.

Patrice Toney, Budget Director, provided the staff report for this item.

Mayor Pro Tem Adams requested a backwards glance of the debt service fund reserves beginning with 2010 and more in-depth information regarding the American Rescue Plan Act.

Council Member MacIntosh suggested to reduce the tax rate by one cent.

Mayor Joines stated he supports lowering the tax rate by one cent.

Council Member Clark stated that Durham is a close comparison to Winston-Salem but has very little nontaxable property. He requested an explanation of the difference. He requested information regarding the cost of LED lights and the economic return for using them and requested WSTA ridership by year, noting that Route 100 transports an average of 8 people.

2. Finance Committee Changes to the Proposed Budget.

Council Member MacIntosh stated he would like to reduce the tax rate by 1 cent and would like to fund \$25,000 more to the downtown partnership in six months if the sales tax rates stay at the same level.

Council Member Taylor stated he supports the crime prevention plan and reducing the tax rate by one cent.

Mayor Pro-Tem Adams stated she would like to a two-cent reduction but would compromise with a one cent reduction in the tax rate.

3. Consideration of a Recommended Budget and Property Tax Rate.

A motion was made by Taylor, seconded by Mayor Pro-Tem Adams, to adopt the budget with a change of one cent reduction to the tax rate (61.24) and add the \$1.35 million for the Crime Prevention Plan. Motion carried with the following vote:
