## RESOLUTION AWARDING CONTRACT FOR ELEVATOR MAINTENANCE SERVICES

**WHEREAS**, The Property and Facilities Maintenance Department has a need to contract services for routine elevator maintenance and needed repairs on twenty-three elevators in various locations around the City; and

**WHEREAS**, On August 4, 2020 Purchasing issued a request for proposal to provide these services to the City and on August 21, 2020 two proposals were received but were rejected as non-responsible; and

WHEREAS, On October 1, 2020, the Region Four Education Service Center, based in Houston, Texas and in partnership with Omnia Partners, a national cooperative purchasing group, awarded competitive bid contract SC-R150801-308841 per bid specification for Elevator Industry Equipment, Repair, Related Products and Services to Thyssenkrupp Elevator Corporation of Alpharetta, Georgia; and

**WHEREAS,** Thyssenkrupp Elevator Corporation has offered the City a five-year contract based on line item pricing contained within this agreement at an annual cost of \$46,044; and

WHEREAS, terms of the agreement allow a maximum four percent annual increase in each of the additional four years of the contract, making the total potential value of the contract \$249,389.16; and

**WHEREAS,** N.C.G.S. 143-129(e)(3) authorizes "purchases made through a competitive bidding group purchasing program, which is a formally organized program that offers competitively obtained purchasing products and services at discount prices to two or more public agencies"; and

Winston-Salem City Council APPROVED March 22, 2021

**WHEREAS**, it is the recommendation of the Finance Committee that a five-year contract be awarded to Thyssenkrupp Elevator Corporation per Omnia Partners contract SC-R150801-308841 for elevator maintenance services at various locations in the initial annual amount of \$46,044 with a maximum four percent increase in the subsequent four years, making the total potential value of the contract \$249,389.16.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Winston-Salem, that a contract is hereby awarded to Thyssenkrupp Elevator Corporation for elevator maintenance services per Omnia Partners contract #SC-R150801-308841 for an initial term amount of \$46,044 with a maximum annual increase of four percent in the subsequent four years, making the potential total value of the contract \$249,389.16. This recommendation is in accordance with N.C.G.S. 143-129(e)(3).

**BE IT FURTHER RESOLVED** that award of this contract constitutes a preliminary determination as to the qualifications of the bidder. The City is not legally bound to perform the contract until the contract is duly executed by the City.

**BE IT FURTHER RESOLVED** that funding is included in the FY 2020-21 budget to cover the cost of these services through June 30, 2021, with funding thereafter subject to future budget appropriations.
