

**ORDINANCE RENEWING THE CERTIFICATE OF PUBLIC CONVENIENCE  
AND NECESSITY OF CAMEL CITY PROMOTIONS INC. FOR THE OPERATION OF  
ONE GOLF CART IN THE CITY OF WINSTON-SALEM**

**BE IT ORDAINED** by the City Council of the City of Winston-Salem as follows:

Pursuant to Section 78-49 of the Winston-Salem City Code, the City Council of the City of Winston-Salem does hereby renew the Certificate of Public Convenience and Necessity of Camel City Promotions Inc. to operate one golf cart in the City of Winston-Salem. In granting the renewal, the Council finds the following:

The owner of Camel City Promotions, Inc. has applied for a renewal of a Certificate of Public Convenience and Necessity for the operation of one golf cart. The certificate was originally issued on to Mr. Reid Hinsley and Mrs. Kristen Hinsley D.B.A. Camel City Promotions Inc. Mr. and Mrs. Hinsley has requested their authorized vehicles under the certificate be decreased from two to one. There have been no other changes since February 1, 2016.

The passage of this ordinance constitutes a renewal of a franchise which is granted subject to the provisions of Chapter 78 of the Winston-Salem City Code and all other ordinances governing the operation of vehicles for hire in the City of Winston-Salem, and all applicable laws of the State of North Carolina, as same are now in effect or as may hereinafter be enacted or amended.

This franchise is not transferable except as provided by law.

The City Council reserves the right to revoke this franchise in its discretion.

Pursuant to Section 78-49 of the Winston-Salem City Code, the City Council of the City of Winston-Salem does hereby revoke the Certificate of Public Convenience and Necessity of Safe Ride Transportation to operate ten taxicabs in the City of Winston-Salem. In granting the revoke, the Council finds the following:

The owner of Safe Ride Transportation has applied for a renewal of a Certificate of Public Convenience and Necessity for the operation of ten taxicabs in the City of Winston-Salem. The certificate was originally issued on February 20, 2012 to Mr. Kenard Carter D.B.A. Safe Ride Transportation. There have been no other changes since January 19, 2016.

The passage of this ordinance constitutes a renewal of a franchise which is granted subject to the provisions of Chapter 78 of the Winston-Salem City Code and all other ordinances governing the operation of vehicles for hire in the City of Winston-Salem, and all applicable laws of the State of North Carolina, as same are now in effect or as may hereinafter be enacted or amended.

This franchise is not transferable except as provided by law.

The City Council reserves the right to revoke this franchise in its discretion.
