A presentation was given by Public Safety Attorney, Lori Sykes.

Council Member Larson expressed concern that not releasing video footage would cause a lack of transparency.

City Attorney, Angela Carmon noted if a judge has made a decision to hold footage, there are no promises that an appeal would force the video to be released.

Chair Taylor requested staff provide updates on the statutes.

Council Member Besse spoke of concerns of abuse discretion when a video is withheld from the public.

Mr. David Valata, 1411 Gholsen Street, Winston-Salem, NC, spoke as the voice for the Hispanic Community and as Founder and Director of "Beating Up Bad Habits". Body cams are being used for protection of the public and police officers. He noted the Hispanic community feels that they do not have rights and something needs to be done with the special force teams whom they believe are abusing their power.

Mr. Elfrin Juan Mohammed, 4504 Ransom Road, echoed Mr. Valata's concerns, adding that the Winston-Salem Police Department is operating on what is going on the nation.

Ms Crystal Blackwell, 601 Martin Luther King, Jr. Blvd. Student Organizer Activist. Voiced concerns that video footage that is not released to the public. She stressed the need for true accountability instead of empty actions.

Presentation was given by Deputy City Attorney Alan Andrews on the Citizen's Police Review Board. He noted citizens can file complaints with the employer's supervisor, The WSPD Professional Standard's Office or The City Secretary's Office in City Hall on the first floor.

In response to Chair Taylor, Mr. Andrews answered that at this time, the City does not have anything in place for citizens to file a complaint on-line.

Chair Taylor requested requested staff research feasibility of a web based complaining process.

Ms. Arletha Patterson, 1235 E. 23rd Street, stated some people feel that if they file a complaint against a police office, there will be some type of retaliation. She asked about attending the Police Review Board hearings, how to join and how is the Board is assessed. She also inquired how to get a list of members.

Michael Banner, 515 N. Jackson Avenue Winston-Salem said he is hesitant to criticize the police department. He expressed concern that the Citizen's Review Board was made up of "lovers of police".

Council Member Besse asked staff to communicate with SBI and the D.A.'s office the urgency of wrapping up the MacCrae investigation.

Council Member Larson had questions about the confiscated weapons in storage and the cost of keeping them for evidence. City Manager Lee Garity will provide a report to City Council regarding those costs.

Council Member Larson asked for clarification from Mr. Garity about the finances for SOAR.
