# RESOLUTION FIXING THE DATE FOR PUBLIC HEARING ON A PETITION FOR THE VOLUNTARY ANNEXATION OF APPROXIMATELY 19.765 ACRES KNOWN AS BROOKBERRY FARM – PHASE 11. NOTICE TO ALL PERSONS INTERESTED IN THE ANNEXATION THEREOF

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WINSTON-SALEM** that, in response to a petition filed with the City, a Public Hearing will be held on October 21, 2024, at 6:00 p.m. in the Council Chamber on the Second Floor of City Hall to consider annexation Brookberry Farm – Phase 11, as provided by N.C.G.S. §160A-31. All persons interested in the proposed annexation are hereby notified to appear at this hearing and present their views to the Council. The area proposed to be annexed is described as:

#### Survey Description of Brookberry Farm, Phase 11:

Lying and being in the City of Winston-Salem, Winston-Salem Township, Forsyth County, North Carolina, and more particularly described as follows:

- 8) along the arc of a curve to the left having a radius of 867.57 feet with a chord bearing and distance of South  $10^{\circ}$  03' 13" East 70.83 feet to a 3/4 Inch Iron Pipe Found at a western corner of Lot 577;

- 3) along the arc of a curve to the right having a radius of 425.00 feet with a chord bearing and distance of South 24° 49′ 03″ East 437.85 feet to a 3/4 Inch Iron Pipe Set;
- 4) North 83° 48' 43" West 175.00 feet to a 3/4 Inch Iron Pipe Set;
- 5) along the arc of a curve to the right having a radius of 250.00 feet with a chord bearing and distance of South 10° 04' 05" West 33.83 feet to a 3/4 Inch Iron Pipe Set;

- 12) along the arc of a curve to the right having a radius of 1,125.77 feet with a chord bearing and distance of North 12° 58' 19" West 536.88 feet to a 3/4 Inch Iron Pipe Set;
- 13) North 19° 25' 40" West 93.37 feet to a 3/4 Inch Iron Pipe Set;
- 14) North 17° 50′ 46″ West 95.96 feet to a 3/4 Inch Iron Pipe Found at the southeastern corner of Lot 587 of said Plat Book 74, Page 174 to 176; thence along the eastern and northern property lines of said Lot 587, the following three (3) courses:
