Please state your reason / purpose for closing a portion of said street / alleyway: (i) the right-of-way of Silas Street and the two portions of the right-of-way of W 32nd Street described herein (collectively, the "Unopened Rights-of-Way") were never accepted for public use or opened to the public, and (ii) the portion of the right-of-way of Baity Street (the "Baity Street Portion") is to be demolished in connection with development of the surrounding real property.




