Fire Station #13

After reviewing the scope of work, confirming the relative availability of M/WBE firms, and discussing contract specification, the City's Internal M/WBE Committee identified subcontracting opportunities in the areas of grading, erosion control, landscaping, concrete, painting, masonry, carpentry, roofing, plumbing, and finishes. M/WBE participation goals were set at 19% and 13%.

The contractor solicited quotes from certified firms for any work for which the company is qualified, including the specific trades listed below. The contractor received quotes from certified M/WBE firms for those in *italics*.

With its bid the contractor reached participation of 3% with certified minority-owned businesses and 6% with certified women-owned businesses. Because the established goal for minority participation was not achieved, the contractor was required to provide the City with Affidavit D which documents their efforts to reach the set M/WBE participation goals.

In the review conducted by the M/WBE Citizens Advisory Committee, the contractor must accumulate a minimum of 115 out of 180 points to demonstrate a Good Faith Effort. For comparison, the State of North Carolina requires 50 out of 100 points. The contractor accumulated an average score of 141, thus demonstrating a Good Faith Effort for M/WBE participation.

Holden Building Company Inc. will be required to subcontract a minimum of 3% of this contract with certified minority-owned businesses and 6% with certified women-owned businesses.
