In response to Council Member Mundy, Dr. Cramer stated hiring of clinicians varies in jurisdictions, noting that some are hired from outside entities and some are hired by the Police Department.

Council Member Scippio suggested creating a hybrid model that uses different parts of each model to create a model that works best of our City.

Mayor Pro-Tem Adams thanked everyone for working on this project. She asked for a matrix that details the costs associated with the program for the seven cities in North Carolina that currently have the alternative response model in place.

Wilson Weaver, Assistant Police Chief, provided the staff report for this item.

Lt. Amy Gauldin provided information regarding the Violent Firearm Investigations Team.

In response to Council Member Scippio, Assist Chief Weaver stated that drones are not used for violent crime reduction but are used to help document crime scenes.

Council Member Mundy reminded everyone that Winston-Salem Police Officers receive mental health training.

Council Member Burke thanked Chief Weaver and the Police Department for all they do and commended them on the presentation.
