RESOLUTION AWARDING PURCHASE ORDER FOR MID-SIZE SEDANS

WHEREAS, the Fleet Services Division has the immediate need to replace eight mid-size sedans having high mileage and excessive repair and maintenance costs; and

WHEREAS, bids were received on August 19, 2019, for the purchase of eight mid-size sedans and the following bids were received;

WHEREAS, on October 26, 2015, the State of North Carolina awarded contracts for passenger vehicles and Horace G. Ilderton, LLC was awarded competitive bid contract #070A per bid specifications; and

WHEREAS, Horace G. Ilderton, LLC has offered a quotation for eight model year 2019 Dodge Journey passenger vehicles at a cost of \$17,524 each for a total cost of \$140,192; and

WHEREAS, N.C.G.S. 143-129(e)(9) authorizes "Purchases from contracts established by the State or any agency of the State, if the contractor is willing to extend to a political subdivision of the State the same or more favorable prices, terms, or conditions as established in the State contract."; and

WHEREAS, it is the recommendation of the Finance Committee that a purchase order be awarded to Horace G. Ilderton LLC, low bidder meeting specifications, for the purchase of eight model

year 2019 Dodge Journey passenger vehicles in the amount of \$17,524 each for the total amount of \$140,192.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Winston-Salem that a purchase order is hereby awarded to Horace G. Ilderton LLC, low bidder meeting specifications, for the purchase of eight model year 2019 Dodge Journey passenger vehicles in the amount of \$17,524 each for the total amount of \$140,192 and that all other bids be rejected. This recommendation is in accordance with N.C.G.S. 143-129(e)(3), and that the bid specifications, the company's proposal, and the City's purchase order will constitute the contract.

BE IT FURTHER RESOLVED that award of these purchase orders constitutes a preliminary determination as to the qualifications of the bidders. The City is not legally bound to perform the purchase orders until the purchase orders are duly executed by the City.

BE IT FURTHER RESOLVED that these purchase are included in the Fiscal Year 2019-20 capital budget and will be financed through the North Carolina Municipal Leasing Corporation with funding for the lease payments available in the Fiscal Year 2019-20 General Fund budget.

BE IT FURTHER RESOLVED that the City may reimburse itself for the capital expenditures identified herein with the proceeds from the sale of debt obligations.
