Mr. Gregory Turner, Assistant City Manager, gave the staff report on this item.

Mr. Turner stated because the petitioners do not demonstrate a hardship. They would not likely receive a variance from the zoning board of adjustment. To do so, staff would need to review a site plan, and the petitioner has been asked to provide one.

Mr. Turner gave the staff report on this item.

Council Member Montgomery stated because some of the alleyways in certain areas of the City face specific challenges associated with not being maintained. He suggested those areas could be offered to persons wishing to be responsible for maintaining them. He cited examples such as, overgrown grass areas, and water main issues that run through the alleyways. He also noted the City should offer incentives for closing alleys.

Council Member Larson requested staff explore the possibilities of how to keep the alleyways servicable so that citizens can use them.

Chair Besse questioned since the City has never accepted public responsibility for an alleyway, would the City then have the authority to close said alleyway.

Mrs. Angela Carmon, City Attorney, responded there is language in the statutes that would allow this be done.

Council Member Larson requested staff explore the feasibility of surplus properties that could go into the private sector. He also inquired about the locations of alleyways located and that are actually servicing residents. He requested information that would indicate the functionality of the alleyways and who is utilizing them.

Council Member Montgomery suggested an option, allowing residents to request the City retain ownership of an alley on their behalf, while allowing them to maintain it.

Extra Item: Brief Report on Odor from the Waste Water Treatment Plant.

Mr. Turner gave a staff report on this item.

He reported on odor complaints at the Griffith Road Wastewater Plant. One of the problems is a device failure has allowed a substance to drop three feet, and this allows the hydrogen sulfide to come out of the solution and work its way into the atmosphere, which has caused the odor problems. A temporary solution is being developed and will be in place within six weeks.
