# Neighborhood and Built Environment

**Definition:** The community where someone lives, including its physical, environmental, and societal conditions and its impact on individual and family health and well-being.

# Core Pillars of Harm Reduction Based on Neighborhood and Built Environment

- 1) Access to Safe & Supportive Spaces
- Well-designed neighborhoods with **safe public spaces** (parks, community centers) provide alternatives to high-risk environments that may contribute to substance use or violence.
- Supervised consumption sites or harm reduction centers in accessible areas help reduce overdose deaths and promote safer substance use practices.
- 2) Availability of Healthcare and Harm Reduction Services
- Neighborhoods with accessible **healthcare clinics, needle exchange programs, and mental health services** support harm reduction by reducing infections (e.g., HIV, Hepatitis C) and offering treatment options.
- Mobile health units in underserved areas provide outreach and harm reduction resources where traditional healthcare facilities are scarce.

#### 3) Housing Stability and Quality

- Unstable housing or homelessness increases exposure to high-risk behaviors, violence, and limited healthcare access.
- Supportive housing models (e.g., **Housing First**) reduce harm by providing stable shelter and access to social services without requiring abstinence.

#### 4) Transportation and Infrastructure

- Reliable public transportation ensures that individuals can reach harm reduction services, medical care, and support networks.
- Poor infrastructure (e.g., lack of sidewalks, unsafe streets) can increase barriers to accessing necessary health services.

## 5) Environmental Safety and Crime Prevention

- High-crime areas may discourage individuals from seeking harm reduction services due to fear of violence or law enforcement encounters.
- Community-led safety initiatives and **violence prevention programs** help create environments where harm reduction services can be more effective.

## 6) Access to Nutritious Food and Clean Water

- Food deserts (areas with limited access to fresh, healthy food) contribute to poor health outcomes, exacerbating vulnerabilities to substance use and chronic disease.
- Clean water access is essential for hygiene, preventing infections, and improving overall well-being.

- Partner with Students for Sensible Drug Policy in Forsyth County


#### Wake Forest


# **Geographic Statistics**



2023 Forsyth County Overdose Response Locations


## **Overdose Ratio by Zip Code**

## **Improvements for Harm Reduction**

- Expand outreach projects, in partnership with Twin City. While many of the organizations listed above have opposing missions to community outreach, the Coalition of Drug Abuse Prevention and Green Tree Peer Center are great opportunities for collaboration
- Install Prescription Medication Drop Boxes/Syringe Boxes at Parks and Recreational Centers to reduce the misuse and reuse of drugs and syringes
- Marketing developments to make knowledge more accessible for support groups, narcan accessibility, and community outreach projects
- Utilize geographic statistics to pinpoint more vulnerable areas in Winston-Salem for harm reduction
- Install more no-cost narcan distribution stations





Housing growth keeps pace of household growth






## Walkability of W-S:

Winston-Salem Parks and Recreation Locations:


Parks and Recreational Areas serve to reduce stress, improve mental health, reduce air and water pollution, as well as mitigate urban heat islands (CDC 2025).

The City of Winston-Salem manages "79 parks that include 51 picnic shelters, 47 playgrounds, 43 soccer fields, 47 softball fields, 109 tennis courts, 8 pools, 6 volleyball courts, 25 basketball courts and a football field." (City of Winston Salem 2022).

Winston-Salem has more than 25 miles of greenways, incorporating paved and unpaved trails, boardwalks, and bridges.
